AGREEMENT

1. PAWS reserves the right to confiscate the above animal should it be found that the animal is not being adequately fed sheltered or the animal is being mistreated, in which case all rights to the animal will revert to PAWS.
2. In the event of having to relinquish ownership of said animal, PAWS must be contacted in order to arrange for a home check of any property the animal is being transferred to. It is also necessary for PAWS to have updated information of this animal for our records and for the microchip registration.
3. The Adopter may, at his option and expense, take the animal to a veterinarian of the Adopters choice for a complete health examination.
4. If the above animal is found to be unsound, PAWS has the right to have the above animal re-examined by a veterinarian of PAWS' choice.
5. If the above animal is found to be unsound by the PAWS' veterinarian the Adopter then has the option of a full refund or adoption of another animal.
6. If no suitable animal is available at the time a full refund will be given to the Adopter.
7. The original animal is to be returned to PAWS at the Adopter's expense.
8. All of points 3 to 7, must be done within a week from the date of receipt of the above animal by the Adopter.
9. The Adopter agrees by his signature below that he is not purchasing the above animal for resale.
10. If the animal is not sterilised, the adoption fee for the animal will include the cost of sterilisation at a veterinarian of Adopter's choice at age of 6 months.

PAWS adoption fee of R..... includes first vaccination and sterilizing of animal at appropriate age, 6 months or older and micro chipping of dogs.
